-Making even of milling support -Roughing of geometry -Removing of clamps, if possible over night -Clamping -Finishing

For bonding and repairing we recommend our products "Adhesive for ebaboard 135" and "Putty for ebaboard 135".

In General

ebaboard material is available in specified sizes. The surface is machined on all sides. **ebaboard** is a synthetic, post-cured board material on polyurethane base. It has an even structure and plane parallel machined surfaces.

Advantages:

Dense structure Good edge strength Low tension Good workability Low dust development when milling

Dimensional tolerance of 1-2 % is possible.
